Subject:- Implementation of PRASHAST (Pre- Assessment Holistic Screening Tool)-A Disability Screening Checklist for Schools & National Guidelines and Implementation Framework on Equitable and Inclusive Education.

Madam/Sir,

As you are aware, Ministry of Education has developed a Disabilities Screening Checklist for Schools and an Android Mobile App titled as PRASHAST Mobile App -"Pre-Assessment Holistic Screening Tool" for schools which will help in screening 21 disability conditions recognized in RPwD Act, 2016, at the school level and will generate the school-wise report. Following instructions may be given to KVs:

- 1. All regular teachers (Class teachers / co-class teachers ) have to download and assess all students from Class I to XII through the app as per the directions given in the booklet (Copy enclosed) to identify Children With Special Needs
- 2. Further Special educators/Counselors/Principal or experts of KVs have to validate the screening of students already screened by regular teachers (Class teacher/Coclass teacher) using PRASHAST Part-1.
- 3. Monthly data of no. of children assessed is to be communicated to this office as per the format attached (Annexure I ) on email id actrgkvshq@gmail.com by the last date of the month.
- 4. Schools wise data sheet along with the filled checklist for all 21 disabilities (where applicable), provided in PRASHAST Part-2 to be maintained in one single booklet by per KV.

Further, Ministry of Education has also notified National Guidelines and Implementation Framework on Equitable and Inclusive Education may be shared with KVs for sensitizing all employees and compliance of Guidelines

Hence, it is requested to issue necessary directions to all KVs under the Region for information and necessary compliance.
